SB 851	Cervantes	Requires a state or local agency or political subdivision to provide written notice to the Secretary of State and the Attorney General after it files or is served a court action relating to elections which contains a claim arising under federal law. Expands existing law that makes it a crime for a person who hires or arranges for any person with a firearm or a uniformed officer, as defined, to be stationed in the immediate vicinity of a polling location such that it applies to such a person or officer outside a county elections office without authorization of the appropriate elections official. Repeals requirements that standards for testing of voting equipment in the state must meet or exceed standards set by the federal Election Assistance Commission. Makes it a crime to use misleading unofficial ballot return envelopes. Clarifies that the duty to certify election results is a ministerial duty of the elections official.	Signed 10/1/25 Chapter 238
SB 852	Elections & C.A. Committee	Makes it discretionary, rather than mandatory, for the California Citizens Redistricting Commission to fill a vacancy that occurs after the end of a year ending in the number two.
